



# **AUDITIONS** / December 2023

The Minas Gerais Philharmonic Orchestra announces the opening of audition process to be held on December 2<sup>nd</sup>, 2023 to fill the following positions:

Double Bass (Assistant Principal): 1 (one) position

#### 1. Application

Applicants must register exclusively through the electronic form available at <u>fil.mg/auditions</u>, from September 27<sup>th</sup> until 11:59pm (Brazilian time) of November 6<sup>th</sup>, 2023.

Only highly qualified candidates should apply.

Incomplete registrations or registrations made after the deadline established above will not be considered.

Applications will not be accepted by telephone, mail, nor e-mail.

#### 2. Required documentation

Candidates should send by e-mail:

- a) Online application form;
- b) Curriculum Vitae (in Portuguese, Spanish or English);
- c) Copy of passport (pages with personal information and photo);
- d) A letter of recommendation (in Portuguese, Spanish or English);
- e) Proof of professional experience of more than two years or a master's degree.

### 3. Compensation

Gross amount of approximately R\$ 174,000 (Brazilian reais) annually.

Additional benefits include health, life and instrument insurance, and other assets according to Brazilian Law.

The value above includes instrument maintenance, copyright for commercial and non-commercial use of orchestra's materials, 13<sup>th</sup> salary, 30-day paid vacation and meal voucher. These conditions may change at the time of the new labor agreement.

## 4. Auditions

# a. Live Auditions

Auditions will take place at Sala Minas Gerais - Belo Horizonte/Brazil.

All expenses incurred in attending the audition (travel, accommodation, meals, among others) will be the sole responsibility of the applicant.

The audition schedule will be individually communicated until 11/10/2023.





#### b. Video Auditions

Video auditions are accepted but not preferred. The Audition Committee will give more weight to a live auditions than to the ones submitted online. If the candidate prefers to send a video, it must follow the rules below:

- a) All required excerpts described in the repertoire list must be recorded in the order provided, without pause. However, it will be allowed that the recording of the orchestral excerpts and the solo be made at different times, each one of them, nonetheless, without interruption;
- b) Videos can be sent using YouTube, Dropbox, or other commonly used cloud methods only. Make sure the video is accessible. Inaccessible videos automatically cancel the application;
- c) Physical media such as CDs, DVDs, flash drives, will NOT be accepted;
- d) The link to the recording must be inserted in the form at the time of application.

The applicant will be automatically disqualified if he/she fails to meet any of the requirements listed above.

#### 5. Miscellaneous

The Philharmonic Cultural Institute will make a prior analysis of the resumes submitted and reserves the right not to select all applicants to participate in the audition process at Sala Minas Gerais.

Applicants who do not receive confirmation of their application by **11:59pm of November 10**<sup>th</sup>, **2023**, should contact the Philharmonic Cultural Institute at audicao@filarmonica.art.br.

Approved candidates should be available to move to Belo Horizonte, Brazil, at the earliest opportunity (pending legal working visa process).

Approved candidates will be hired under the Brazilian Labor Laws regime and will undergo a probationary period of at least 01 (one) year with the Minas Gerais Philharmonic Orchestra.

The audition may consist of several stages to be determined by the Audition Committee.

The Audition Committee may interrupt the process at any time.

Solo pieces must be executed without piano accompaniment.

The orchestra will not be responsible for travel, lodging nor transportation expenses.

All candidates should check-in 30 minutes before their assigned time.

The Philharmonic Cultural Institute reserves the right not to fill the total number of positions offered.

By submitting the application form, the candidate confirms that he/she is aware of and agrees with all the conditions required to participate in the audition.
